164.13 Public participation session with respect to items on the agenda and other matters that are of mutual interest: no public present

**165.13 To receive report from Police:** There had been no reported crimes in East Mersea but heating oil thefts had taken place in West Mersea. We have requested 'slow' signage along Church Lane for people going to Coopers Beach.
