28.21 Apologies for absence: None

- **29.21** To confirm the minutes of the Parish Council meeting held on 11th February 2021: Cllr David Sunnucks proposed, Cllr Emma Green seconded and all agreed that the minutes were a true record of the meeting and will be signed by the chairman, with the exception that Minutes Item 22.21 West Mersea Neighbourhood Plan was not discussed at the meeting but was a post-meeting note added as the result of an email from Cllr Glover dated 12th February.
- **30.21 Declarations of Interest:** Cllr Sunnucks for application 210411 (and 210412).
- **31.21 Public Session:** The suggestion of extending a footpath was discussed but thought not to be a reasonable or viable idea. A post covid village party was discussed briefly and will be on the next agenda.
- **32.21 County Clir report:** Covid infection rate in Essex is falling dramatically but vigilance is still required and the vaccination programme is going well. The Adult Social Precept part of the County Council tax is going up but other parts are not. Primary schools are the responsibility of ECC and have successfully all reopened. A proposed meeting by a resident with County Parks will include representation of the parish council and the parking department.
- **33.21 Borough Clirs reports:** The full council met to determine the future CBC budget. Clir Buston was welcomed to the meeting and he explained in detail what the CBC Licencing Committee is capable of achieving with regard to the long running problem of residency at the caravan parks.
- **34.21 Speeding in East Road:** Training for use of speed guns will be looked into again as it may now be possible with the end of restrictions in sight. Volunteers will then be sought to take this up to operate along East Road.
- **35.21 Noticeboard:** The price for the new one was agreed by all and has now been installed at the far end of East Road.

- **37.21 Poopy Appeal:** It was agreed by all to support this very worthy cause with £200, having missed contributing last year.
