**85.21 County Councillor report:** Concerns over the bend in Bromans Lane were discussed bearing in mind that more people may possibly visit Cudmore Grove this summer holiday as people are staying in this country more this year. Following the meeting of several years ago with ECC officers and other interested parties, phases one and two of the proposals were implemented and have reduced problems significantly and so phase 3 will be looked into which would address this particular bend and, in the meanwhile, marshalling will be requested at busy times to help keep the flow of traffic moving as smoothly as possible.

86.21 Borough Councillor report: None.

**87.21 Footpaths:** Following reports of local footpaths (Nos. 20 & 18) being overgrown we have been informed that ECC has them on its schedule for attention. In September the parish council will form a Footpaths Working Group for local people to get involved in addressing overgrown footpaths more often that ECC can manage.

Another date will be considered in due course, possibly during the Christmas period.
